# MINUTES OF KEYWORTH ANNUAL PARISH MEETING HELD THE VILLAGE HALL ON MONDAY 24<sup>th</sup> APRIL 2023 AT 7.00PM

#### 1. Chair's Welcome

Cllr Tamsin Armour welcomed everyone to the meeting.

#### 2. Apologies

Apologies had been received and accepted from Cllrs Lumb and Wells. Borough Cllr Inglis also sent his apologies.

## 3. Approval of the Minutes of the 2022 Annual Parish Meeting

The minutes of the Annual Parish meeting on 25<sup>th</sup> April 2022 were **APPROVED** and signed by Cllr Armour as a true record.

## 4. Chair's Report on Parish Council Activities 2022/23

Cllr Armour highlighted the following from the full report which is available on the Parish Council website (www.keyworthparishcouncil.org/chairmans-report) or can be obtained from the Council office:

As we continue to live with a world post-COVID-19 other issues have hit the headlines and impacted on people's lives. The cost-of-living crisis, the war in Ukraine, the Platinum Jubilee and then subsequent death of the Queen have been in the headlines and have been foci of Parish Council activities and discussions and we strive to support those in need and celebrate and commemorate respectively.

Support for those in need, via foodbanks, warm spaces, and other activities continues. Demand has been high, unsurprisingly, given increases in the cost of living. I have met with Positive Futures and heard some wonderful examples of the work they are doing. I am really keen to see young people from Keyworth benefit from the support and opportunities they offer. English lessons for the Ukrainian residents of Keyworth have been supported by the Parish Council, providing space, refreshments, and some funding for equipment. The Keyworth Community Garden goes from strength to strength and provides a safe space to support mental health and wellbeing, as well as providing volunteering opportunities and a

brilliant community asset. These initiatives and programmes would not be possible without the dedication of the organisers, often volunteers, and once again I would like to take this opportunity to say a massive 'Thank you' on behalf of myself and the Parish Council, to all those who have given their time and energy to continue to help others. You are amazing and Keyworth is a safer and better place to live thanks to your wonderful teamwork. This year saw a return of our regular PC Reception, where we were able to say thank you in person to many of these wonderful members of our community.

This year saw several events both of celebration and remembrance. The Queen's Platinum Jubilee celebrations started with the lighting of a beacon on the Rectory Field, followed by a range of events in the Village Hall and the ExChanging Rooms/Abundance Garden, a community picnic and family entertainment. We celebrated 70 years of Keyworth history with a fascinating display put on by CAAG and the Keyworth & District Local History Society in the Centenary Lounge. The Tour of Britain came to Keyworth again, celebrated by decorations around the Church, in shops and houses, many adorned with bike illustrations created by children from the three primary schools, banners and the wonderful awardwinning land art, created by Wild Things Keyworth, Keyworth Abundance and artist Liz Waddell. Later in the year members of the village joined together to pay their respects to the Queen, with a service to reflect on her life and mourn her passing. A week later saw the official opening of the extended Skatepark with some excellent skateboarding skills and some attempts by Parish Councillors that we might do best to forget! The annual Remembrance Sunday Service by the Memorial Gates took place with a full complement of Beavers, Scouts, and Guides, remembering those who gave their lives in the two world wars - some of whose names now identify roads in the new housing developments in the village. Finally, as the year drew to a close The Festivities Day was a wonderful way to bring everyone together in the approach to Christmas.

## **Council Members**

The current members of council are: Tamsin Armour (Chair), Tony Wells (Vice-Chair). Tom Atack, Geoff Baker, Mary Butler, David Clarke, Kevin Fitzgerald, Tony Grice, Samantha Kaye, Chris Kemp, Kev Lowe, Richard Lumb, Kath Oakley, Shelley Millband, Chris Takel. Following the resignation of Matthew Tuttey and Ian Bell in 2022, Richard Lumb was co-opted to council in September 2022.

#### **Council Staff**

The Council currently employs six part-time members of staff including the Clerk to the Council Michelle Law Emma Goodman, who has recently taken over from Emma Tillyard, as the Responsible Finance Officer. The council also employs Helen Bradshaw as the Clerical Officer, Steve Mottishaw as the Facilities Manager, Sam Daft as the Cleaner and Alan Wilkins as the Handyman. The total basic hours worked by these staff equates to the hours worked by three full time staff.

## **Council Facilities**

- The Council owns, or is responsible for:
- The Village Hall complex including the Village Hall, Centenary Lounge and Feignies Room
- Rectory field and the Peace Garden
- Keyworth Activity Park
- Rectory field Pavilion and former Changing Rooms (occupied by Keyworth Table Tennis Club and Keyvolution/Abundance respectively)
- Memorial Gates
- Wysall Lane Burial Ground

- Nottingham Road Play Area (leased from the Equals Trust and Nottinghamshire County Council)
- Platt Lane Skatepark (leased from UK Research & Innovation)
- Keyworth Meadow (managed by the Nature Reserve Management Group)
- Keyworth Bowls Club clubhouse and green (managed by the club)
- Keyworth Tennis Club clubhouse and courts (managed by the club)
- Platt Lane recreational field (⅓ interest and managed by the Platt Lane Management Committee)

## Village Hall Complex

- The Village Hall is being hired on regular basis by both new and old customers; the levels of hire have now reached those of pre-pandemic levels.
- The bar area of the Feignies room is still hosting the local Food bank.
- For the 2023/24 financial year, the Council's Finance committee agreed to increase in the hire fees for the Village Hall complex 20%, this has placed them on par with other venues of a similar size in the area.

Nottingham Road Play Area, Rectory Field, Wysall Lane Burial Ground, Activity Park, Skate Park

- All of the play areas continue to be proactively checked and maintained by the Parish Council's Facilities Manager with repairs carried out as needed.
- This year the Skate Park project has been completed, funding was obtained from various sources and a new design Skatepark was built. An official opening of the Skatepark was organised in September 2022, and it was well attended by the local community and the funding organisations. The new Skatepark is currently being well used and seems to be appealing to many members of the local community as well as those from further afield.
- The Council's Finance committee agreed to increase the burial ground fees by 3%, even with the increase, the fees are still some of the lowest in the area.

## **Memorial Gates**

- The paving and area in front of the memorial gates has had its annual clear and tidy up before the Remembrance Day Service, so that the area was clean and tidy for the annual Remembrance Day service.
- The Peace Garden near the memorial gates is maintained on a regular basis by a local company Branch & Bloom.

# **Support for Local Organisations**

- The Council continued in 2022/23 to provide financial assistance to:
- Platt Lane Joint Management Committee (the Council has a one-third financial interest in the facilities at Platt Lane)
- Keyworth & District Community Concern
- Keyworth Conservation Area Advisory Group
- Keyworth PCC (re maintenance and repair of church clock)

- The Keyworth Twining Association

The Council makes its premises available at concessionary rates, and in many cases free of charge, for various community events and services such as:

The Food Bank, Keyworth Advice Centre, Thursday coffee morning; Conservation Group; Keyworth Show; Fun on the Field; Christmas Charity Fair; Remembrance Sunday; Christmas Fair & Christmas Dinner, the Bereavement Support Group and the Keyworth and District Community Concern.

## Parish Council Events/Seasonal Activities

- During the past twelve months, the Council has organised and/or sponsored the following events and activities:
  - Summer Hanging Baskets to decorate the village.
  - Christmas trees to decorate shops and businesses, as well as lights on the trees in the church yard.
  - A village litter pick.
  - The lighting of the beacon for the Queen's Jubilee.
  - A gathering and a moments silence for the passing of the Queen.
  - A place for people to sign a book of remembrance for the queen.
  - Cllr Armour represented the Parish Council at the Remembrance Sunday Event held on the Rectory Field at the Memorial Gates along with representatives from Rushcliffe Borough Council, Nottinghamshire County Council, Churches in Keyworth and the Royal British Legion. Memorial wreaths were laid at the gates.

## Publicity/Information

- The Council website (www.keyworthparishcouncil.org) is updated regularly.
- We also keep residents informed through news items and the Keyworth Diary (in the Keyworth News), distribution of which, to all households in Keyworth, is financed by the Council.
- A new Keyworth Guide was published this year, to mark the Queen's Jubilee.

#### Finance

- At the time of writing, the Council's accounts for 2022/23 have not yet been finalised. The figures to hand suggest that the Parish Council is on budget for the financial year 2022/23. Expenditure was made on a general maintenance of the buildings and facilities including. Expenditure was also made on the events in the village including the Queens Platinum Jubilee, the Keyworth Guide, and the Tour of Britain.
- Income from hire of the village hall complex facilities has increased to beyond those that were recorded to pre COVID-19 levels.
- The Council reviewed its reserves policy as usual in January. On the face of it, the level of the Council's uncommitted reserves (reserves not set aside to fund specific commitments or long-term development plans) might seem high, but it should be borne in mind that the Council owns, and is responsible for maintaining, fixed assets valued at around £1.8 million, and it follows that it needs to set aside substantial funds for emergency/contingency purposes, the pandemic being a current, although non-tangible, example. Uncommitted reserves will be used in 2020/21 and potentially 2020/22 to cushion the financial effects of the pandemic so as to keep increases to the precept modest.
- As for 2023/24, the Council has set its precept at a level resulting in the Parish Council portion of the council tax not increasing for any properties in the village.

## Planning

The council has held 12 planning meetings, reviewing a total of 77 planning applications in the period and has worked with the community and with Rushcliffe Borough Council to ensure the new housing developments on Platt Lane, north of Bunny Lane, and Nicker Hill are appropriate to the area. The Parish Council are also trying to work closely with Rushclifffe Borough Council to represent the views of the Village regarding the development of land at the South of Bunny Lane site.

#### Other Items

- New community bleed kits have been installed alongside the community defibrillators. One of the bleed kits was donated to the Parish Council by the Daniel Baird Foundation, the remaining three bleed kits were purchased by the Parish Council.
- The Council have worked with Severn Trent Water and Trent Barton Buses to limit the disruption that has been inevitable as substantial works have been carried out on the water mains pipe that enters the village from Plumtree.

#### Plans and Priorities for 2023/24

In my view, the Parish Council's most important priorities in 2023/24 will be:

- To continue to look to the future and support and grow the positive sense of community that COVID-19 fostered. In particular to consult residents on our long-term plan for Future Keyworth, helping groups, societies, our Schools and Facilities to form a cohesive set of activities and opportunities, with something for everyone. In addition, to capitalise on any opportunities to secure funding for such projects via sources that are linked to the devolution deal and other targeted funding opportunities. I am keen to see all Councillors have the opportunity to get involved and really make a difference.
- To continue to support those in need across Keyworth. Recent years have been challenging for many, with COVID-19, the war in Ukraine and the dramatic increases in the cost of living meaning many have suffered and many continue to struggle. This will include continuing to ensure food and other essentials are available, finding ways to support those in financial hardship, and ensuring mental health guidance and support are accessible to all those who may need it.
- To continue to work with sports leaders, schools, clubs and other local groups, including Positive Futures, to create an inclusive and accessible activity and wellbeing framework, linking Parish Council facilities with developments at Platt Lane, and other venues, providing sports, exercise and recreational opportunities for all.
- To work with residents and local groups to continue to enhance our environment, including planting more trees and hedgerows, finding ways to enhance and protect the wildlife, be it hedgehogs, birds, bees, butterflies, or my favourite, ladybirds, in and around the village.
- To investigate the possibility of extending neighbouring footpaths, enhancing the village centre(s), working with developers and using CIL funds to improve our environment whilst supporting businesses to succeed.

## 5. Questions from residents

The following questions were presented to the council before the meeting and asked during the meeting from members of the public:

1. What steps is the council taking to support, encourage and develop Keyworth's retail business and associated businesses and amenities such as cafe's, pubs etc?

Background to my question:

Keyworth seems to have a decline taking place in terms of shops closing down, even though the population is growing and Keyworth as a place to live is becoming more affluent. If you take a look at Ruddington by comparison, over the last 3 years they have developed from a place with retail closures taking place, into a thriving retail and social hub for the residents.

Ruddington has developed its offer through its highly successful and well run and promoted monthly market with has a positive profile on social media, and the market seems to be a hub of regeneration the whole area as a whole with bringing wider benefits in terms of the community - social, financial and collaborative initiatives. They have nearly 6000 followers on Instagram.

When you look at events such as The Queens 75 Jubilee, and now the forthcoming Coronation, there are multiple well attended events taking place, that feed from the success of the Ruddington Village Market.

## **Ruddington Parish Council**

As a key member of the Ruddington Village Community Partnership, the Parish Council is committed to and supportive of the activities of the RVCP to drive the prosperity and vibrancy of the village centre.

In June 2018, the Parish Council granted funds to launch the 'Ruddy Good Offers' Loyalty Card scheme and continues to support the initiatives of the RVCP in any way it can, including the Ruddington Village Market.

A discussion took place, and it was **AGREED** that the Parish Council would ask the sender of the question to engage with the Parish Council and their future of Keyworth group. It was further **AGREED** that Cllr Baker and Cllr Moncrieff will be looking into lodging some bids for funding so that the people of Keyworth can be consulted on the future of Keyworth.

Furthermore, it was **AGREED** that Cllr Millband will look into the location of the current Saturday market and see if it is feasible to move it to 'The Square' of Keyworth.

2. At the 2022 Annual Parish meeting, CIL money received was stated as £12000. What is the current figure now? Has consideration been made on how the CIL money should be spent?

The Clerk informed the resident and the Council that they did not have the figure to hand for the current CIL money, and that they would report back to council and the resident what the current figure is. Furthermore, it was **NOTED** that the Parish Council are still investigating what the money will be spent on this year but will update residents once some decisions have been made.

3. At September 2022 KPC Full Council meeting, it stated 'Vision for Keyworth Working Group Terms of Reference to be brought to December 2022 meeting for Council members to agree'. I can find no reference in any minutes to Council Members' agreement. What is the situation?

A discussion took place, and it was **NOTED** that because at this stage the 'the vision for Keyworth group' is only a working group and not a committee, that they do not actually need any terms of reference. If as the group meets and progresses forward with the 'vision for Keyworth' project and becomes a committee then a set of terms of reference will be present to Full Council.

4. Is there any follow-up on the Vision for Keyworth Working Group after September 2022 as there is no detail in Parish Council minutes of any developments since then?

A discussion took place and Cllr Baker explained that the working group is set up currently to just pass ideas around and so that questions can be asked to Rushcliffe Borough Council. Once the group starts making some decisions then minutes will be taken, and residents will be updated.


5. £16,950 approved at October 2022 F&R meeting for Platt Lane Joint Management Committee as part of KPC precept. Does the Joint Management Committee still operate as the KPC External Bodies appendix for 2021/22 dated 21st June 2021 states 'Platt Lane JMC – please note, this body is due to be replaced.'

A discussion took place and it was **NOTED** that the Parish Council do still have members on the management committee and that the management committee have not met recently but when they do next meet the Parish Councillors will be invited to the meeting.

6. I see no reference in KPC minutes to inform Councillors and residents officially that the Platt Lane Playing Fields Association has changed status to Keyworth Sports Association, now operating as a limited company. As residents provide council tax for the annual grant, it would be useful for them to have more information.

A discussion took place, and it was **NOTED** that Cllr Baker gave an explanation that Platt Lane management committee is a limited company but that it was limited by guarantee, and that they became a limited company as it helped to open some more doors for funding for the group. The directors of the limited company are not taking any money from the committee / group.
